



TIMBERLINE CHRISTIAN ACADEMY PRESCHOOL SCHEDULE OF FEES 2026-2027

School will be in session on Mondays - Thursdays from 8:00 to 4:00 PM.

Re-enrollment/Application Fee: Registration fee is non-refundable.

Early (before June 1)	\$200 per child; maximum \$350 per family
Regular (after June 1)	\$250 per child; maximum \$450 per family

Textbook Fees: Curriculum fees are per student and are due July 1.

K2	\$75
K3	\$100
K4	\$150

Additional Fees:

K4 Graduation Fee	\$50	payable by May 1
Mat Fee (one-time fee)	\$30	payable by August 1

Monthly Tuition: All fees are based on a ten-month payment plan with the first monthly payment due on August 1. (School will begin on August 24, 2026, and end on June 3, 2027.)

Tuition Payment Options and Details:

Re-enrollment Fee for Current TCA Families

The non-refundable re-enrollment fee of \$200 per student is due upon re-enrollment through June 1. After June 1, a non-refundable re-enrollment fee of \$250 per student is due upon enrollment.

Application Fee for New Families

A non-refundable application fee of \$200 per student is due upon submitting a new student application through June 1. After June 1, a non-refundable enrollment fee of \$250 per student is due upon enrollment.

Annual Payment Plan

The full tuition for the year must be paid by August 1. The invoiced amount will include a 5% discount if paid in full by August 1.

Monthly Payment Plan

Monthly payments are due the 1st of each month. Payments are considered delinquent after the 10th, and a \$30 late fee will be incurred on the 11th.

New Student Referral Incentive Program

The New Student Referral Incentive Program awards a referring TCA family with a \$250 tuition credit for each new student that is referred to and actually enrolls in and attends Timberline Christian Academy. The tuition credit is applied two times per school year in October (\$125.00) and March (\$125.00). (Refer a family that enrolls two students and receive a \$500 tuition credit; refer a family that enrolls three students and receive a \$750 tuition credit, etc. Cannot exceed the referring family's tuition amount.) The referral program is for parents or guardians who are paying tuition for enrolled students (K2 through grade 7) attending Timberline Christian Academy.

A \$100 incentive award per newly referred K2 through grade 7 student is applied two times per school year in October (\$50.00) and March (\$50.00). Referred students must be enrolled at the beginning of a semester for the referring family to receive their first distribution. (If a referred student begins mid-semester, the referral award distribution will begin during the second semester of enrollment.)

A signed New Student Referral Incentive Program form must be on file in the School Office two weeks prior to the reward distribution (October and March) and a name match must be indicated in the Referral Verification section on the new student's Enrollment Application.

Submission deadlines: September 15th for October award; February 15th for March award.

Turning in a completed Referral Incentive Program form after the deadline will reduce the award by half. Family will receive second distribution only.

Failure to turn in a completed Referral Incentive Program form will make the referring family ineligible for the reward.

Incentive award consideration is limited to the referral of brand new families enrolling students in TCA and does not apply to students transferring, returning, siblings of current TCA students, nor families who have previously had students at TCA within one academic year.

New Student Referral Incentive Program forms will be available in the school office.
